INTERREGIONAL GROUP ON HEALTH & WELLBEING 2020-2025

European Committee of the Regions

For the period 2020-2025, the European Committee of the Regions (CoR) interregional group on health and wellbeing will focus on three core priority themes:

- health inequalities;
- health prevention and promotion;
- health system transformation.

The group will prioritize prevention and promotion, primary care reform and integration between health and social care services, advocate for an economy of wellbeing approach and will aim at contributing to the achievement of the SDGs goals.

For each area, a dialogue will be ensured with the European Commission, key international bodies (such as the World Health Organisation and the OECD), and relevant stakeholders from civil society, industry and academia.





An overview of the issues within the priority themes is illustrated below:

Health Inequalities

Socio-economic, cultural and environmental determinants of health

 Methods to prioritise prevention and support wellbeing across the lifecycle.

Vulnerable people, groups, and contexts

 Foster a health in all policies approach by working with sectors such as spatial planning, which are local & regional competences, supporting Health Impact Assessments.

Regional inequalities in wellbeing within and between EU Member States

 Understand and support development of effective data collection to aid local & regional decison-makers.

Health prevention and promotion

- Discuss policies and interventions to address tobacco, alcohol, physical activity and diet
- Address Primary prevention
- Address Secondary Prevention (eg. cancer screening)

Share good example of regional health plan

Discuss about Vaccines hesitancy

Mental Health

- Follow up of the European framework for Action on Mental Health and Wellbeing
- Promote good mental health and to advance the prevention, early diagnosis, treatment and destigmatisation of mental disorders

- Support the development of this model at the local and regional levels.
- European Innovation Partnership on Active and Healthy Ageing / Political engagement with action groups and support of scaling up strategy.

Health System Transformation

Value-based healthcare and outcomes measurement

- Discuss VBHC and person centred model at regional level
- Address outcomes measurement and data collection
- Discuss new model of procurement
- Training and education of the health workforce

Integration of care and Primary care

- Discuss primary care reform and share good practices
- Learn from different experience in the integration of care (vertical and horizontal)
- Training and education of the health and social workforce

Cross-border healthcare

Make patients mobility a reality. Discuss about revision and further implementation of the Cross-border Directive.

eHealth

- Share Local & regional input into the development of regional e-helath strategies
- · Address eHealth literacy
- personalised medicine
- Contribute to the debate on the European health data space
- Training and education of the health workforce

- Cooperation with European Commission, European Parliament
- Cooperation with WHO-Europe and OECD
- Cooperation with stakeholders (NGOs, academia,industry)

The **objectives** of the interregional group are:

- To promote an understanding of how all sectors affect the health of citizens and communities, and that, subsequently, a multi-level governance approach is needed to improve and sustain health and wellbeing across Europe;
- To share ideas and knowledge on the **investments to support effective**, **accessible and resilient health systems and improve the health of society**. This should emphasise the role of local and regional governments, in particular the implementation of the European Structural and Investments Funds;
- To exchange experiences on current challenges in relation to implementing health system
 reforms in a climate of limited resources and rising demand, stressing the use of EU tools
 such as the Structural reform support programme;
- To enable discussions on regional and local policy initiatives to build **cohesive and sustainable communities** that promote and enable healthy behaviours;
- To pay close attention to **vulnerable groups** in society, including those with disabilities, and **address mental health equally with physical health** by mainstreaming a health equity perspective throughout the group's work;
- To inform CoR Members of the latest research and innovation in relation to tackling the major chronic diseases and burden of multi-morbidities in an ageing population, as well as mission-related objective (eg. Cancer) and partnership on Health and care system transformation under Horizon Europe;
- To explore means and opportunities to facilitate in-depth discussions of the group, without presenting any additional resource or administrative burden on the CoR;
- To communicate effectively with CoR officials to ensure the work of the group is complementary and supportive to ongoing CoR business;
- To continue positive and meaningful **cooperation** with DG Health and Food Safety (DG SANTE) of the European Commission as well as any other relevant DGs, European Parliament, WHO-Europe and OECD.





Working method

The group will be composed of 1 permanent Chairperson (Birgitta Sacrédeus, EPP) and a bureau of members who committed to support the development and review the progress of the group.

The interregional group plans to meet at least 4 times per year in line with the respective Plenary sessions of the European Committee of the Regions. The bureau of the group meets at least once per year in person. The secretariat of the interregional group on health will be provided by the European Regional and Local Health Authorities association (EUREGHA).

A <u>dedicated webpage</u> for the group is created within the EUREGHA website to communicate about events, meetings and any relevant news. The page will contain information about the Chair, bureau and members and reports of all the meetings.
